The Republic of Belarus has received financing from the World Bank in the amount of USD 125 million in equivalent toward the implementation of the Belarus Health System Modernization Project, and intends to apply part of the proceeds toward payments under the Contract for "Procurement of Medical equipment and medical devices to be installed for the "cleanrooms" of the construction object "Republican Scientific and Practical Center Mother and Child. Reconstruction of the anesthesiology and resuscitation unit with intensive care wards for newborns".

**Republican Scientific and Practical Center for Medical Technologies, Informatization, Administration and Management of Health (RSPC MT)** now invites sealed bids from eligible bidders for the supply of Medical equipment and medical devices to be installed for the "cleanrooms" of the construction object "Republican Scientific and Practical Center Mother and Child. Reconstruction of the anesthesiology and resuscitation unit with intensive care wards for newborns". The maximum period of delivery of equipment, including assembly, installation, connection and training, is 70 days.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's [\*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers\*](#) (published in January, 2011, revised in July 2014) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
